RONALD MCDONALD HOUSE CHARITIES OF AMARILLO recently unveiled the new SUNSHINE FOR CHARLOTTE PLAYGROUND which serves area families who must travel to Amarillo to receive medical treatment for their children and call the Ronald McDonald House their "home away from home." The new playground is ADA accessible, preschool friendly (the majority of children staying at the House are 9 years of age or younger), and offers interactive, educational, and fun features geared toward younger children in what will likely be the most stressful season in their families' lives. The funds to cover the new playspace and surrounding turf landscaping were made possible by race funds from last year's Sunshine for Charlotte 5K & Family Fun Day - a yearly fall tradition for the Ronald McDonald House. Since Sunshine for Charlotte was first organized and hosted in collaboration with the Ronald McDonald House in 2021, the event has raised enough funds to sponsor a Sunshine for Charlotte guest suite in the newly rebuilt House, fully fund 2 full years of family stays in that suite, and cover the expenses to build this new playground. Since first opening its doors in 1983, RMHC of Amarillo has

provided more than 75,000 nights of lodging to families when they need it most. Additionally, the organization delivers more than 2,500 gifts and toys to pediatric patients in area partner hospitals each year, and serves upward of 5,000 visits to guests at the Ronald McDonald Family Room at Northwest Texas Healthcare System.
